Juried Exhibition: Jurying will be done Saturday August 18th. Not all work will be accepted due to limited space.

Jury notification Sunday August 19th

<u>Eligibility:</u> All artists in all mediums are welcome (2D & 3D).

Non-refundable Entry Fee: \$25 for 1 or 2 entries.

Juror: Robin Purcell

<u>Awards:</u> There will be no separate categories for judging. Cash awards & ribbon prizes will be given for Place awards (1st, 2nd, 3rd), in addition to a Best of Show. Ribbon awards will be given to Honorable Mention winners.

Show Rules:

Original Work: 2D and 3D artwork must be the artist's own original work and not previously shown at an ADAS juried show. *Not accepted:* Giclees, work based on other artist's work or published photographs, work done under the supervision of an instructor, or in a workshop.

Content limitations: No overt political statement or frontal nudity please. The show committee will make the determination of appropriate art at receiving.

Volunteers: Assistance is needed in the following areas:

- o Receiving of artwork
- Staffing of the exhibit
- o Hanging of artwork
- o Reception staffing
- o Management of art pick-up

Sculpture (3D) Pedestals to be provided by the gallery for sculpture. Covered cases for 3D art.

Wall art (2D) must be framed or edges of gallery wrapped canvas painted. Hanging hardware must be flush-mounted. Ends of wires must be taped. No sawtoothed hangers. For covered artwork, Plexiglas, not glass is preferred. All artwork must be tagged when you deliver it. The tags must agree with the application or it can not be accepted.

Insurance: Artwork for the exhibition will be insured by the Town of Danville from the time it is received and inspected by the gallery. Insured against all physical loss or damage. If damage occurs and the piece can be repaired, liability will be limited to the cost of that repair.

Sales: The Village Theatre Art Gallery will process any sales. <u>A 40% sales commission will apply</u>. The artist who sells a painting at the Gallery will get a 1099 at the end of the year. **Any Questions?** To learn more about ADAS visit our website at www.adas4art.org.
